WHEREAS, Section 455 (b)(1)9(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod";

WHEREAS, Section 2, of Republic Act no. 7279 otherwise known as the "Urban Development and Housing Act of 1992", provides that, "*it shall be the policy of the State to undertake, in cooperation with the private sector, a comprehensive and continuing Urban Development and Housing Program, which shall: (a) Uplift the conditions of the underprivileged and homeless citizens in urban areas and in resettlement areas by making available to them decent housing at affordable cost, basic services, and employment opportunities";*

WHEREAS, Rotary Homes District 3830 Development Foundation, Inc. a civic organization existing under Philippine laws with address at Gemphil Compound, Lourdes Street, Teoville West 3 Subdivision Sampaloc 1, Brgy BF Homes Paranaque City and represented by its Chairman Suzanne v. Sta. Maria, proposed to undertake a project with the City of Muntinlupa entitled Rotary Homes-Muntinlupa Village 1 or the PROJECT;
