FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH AYANA CONSTRUCTION CORPORATION FOR THE PROJECT COMPLETION WORKS FOR THE SITE DEVELOPMENT & CONSTRUCTION OF FLOOD CONTROL SYSTEM LOCATED AT COLEGIO DE MUNTINLUPA, POSADAS AVE.
