A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH LAS PIÑAS-MUNTINLUPA DISTRICT ENGINEERING OFFICE, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-NATIONAL CAPITAL REGION (DPWH-NCR), REPRESENTED BY OIC-DISTRICT ENGINEER ELPIDIO Y. TRINIDAD, FOR THE CONSTRUCTION AND PROVISION OF ISOLATION FACILITIES AND SHELTERS FOR HEALTHCARE WORKERS TO BE LOCATED IN PACWOOD, BARANGAY TUNASAN, THROUGH THE "WE HEAL AS ONE OFFSITE DORMITORY FOR MEDICAL PERSONNEL".

WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, "the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod";

WHEREAS, Republic Act No. 7160, empowers the Sanggunian to approve ordinances and pass resolutions necessary for an efficient and effective government, and in this connection shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities xxx";

WHEREAS, the Las Piñas-Muntinlupa District Engineering Office, DPWH-NCR is an agency of the National Government with principal office address at 2nd Street, Port Manila, duly represented herein by OIC-District Engineer Elpidio Y. Trinidad;

WHEREAS, the City Government of Muntinlupa in view of with the Covid-19 Public Health Crisis, requested the DPWH's assistance in construction of isolation facilities/and/or providing shelters for their offsite frontliners and other healthcare workers through the "we heal as one offsite dormitory for medical personnel" to alleviate the daily operational challenges during this crisis;

WHEREAS, the DPWH shall undertake the preparation of the conceptual plan of the proposed city government of Muntinlupa isolation facility/off-site dormitory, procurement and the corresponding construction, management and supervision of the project;

WHEREAS, the funds for this proposed project will be taken from the appropriation released to the DPWH-Las Piñas – Muntinlupa District Engineering Office (DEO) through the FY 2020 General Appropriations Act (GAA);

WHEREAS, that the operation of the said project after its completion, shall be undertaken by the City Government of Muntinlupa following the necessary health standards and protocols;

WHEREAS, the Isolation facility/off-site dormitory will remain as property of DPWH and may be dismantled and removed on site after the pandemic and the structure is no longer necessary;

WHEREAS, the Legal Office interposes no objection to the Memorandum of Agreement (MOA);

WHEREAS, the location of the project shall be constructed within the compound of PACWOOD Site, Barangay Tunasan as offered by the City Government of Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi** in behalf of the City Government of Muntinlupa to sign and enter into a **Memorandum of Agreement (MOA)** with **Las Piñas-Muntinlupa District Engineering Office, Department of Public Works and Highways-National Capital Region (DPWH-NCR)**, represented by **OIC-District Engineer Elpidio Y. Trinidad**, for the construction and provision of isolation facilities and shelters for healthcare workers located in Pacwood, Barangay Tunasan, through the "We Heal As One Offsite Dormitory for Medical Personnel".
