WHEREAS, Rule IX, Article 47 of the Rules and Regulations implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned;

**WHEREAS**, the United Nation's Declaration of Population stated that the population problem is a principal element in long-range national planning hence the essential aim of the population program is the social, economic and cultural development of countries;

WHEREAS, Republic Act 6365, created the Commission On Population which is tasked to formulate and adopt coherent, integrated and comprehensive long-term plans, programs and recommendations on population as it relates to economic and social development consistent with and implementing the population policy;
