BATAN, UNDERSECRETARY FOR RAILWAYS AND THE PHILIPPINE NATIONAL RAILWAYS (PNR) REPRESENTED BY GENERAL MANAGER JUNN B. MAGNO FOR THE CREATION OF A RESETTLEMENT ACTION PLAN IMPLEMENTATION AND MANAGEMENT COMMITTEE (RIMC), LIKEWISE ADOPTING THE GENERAL AND PARTICULAR PROVISIONS AND THE TERMS OF REFERENCE INCLUDED THEREON.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent t, city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned;

WHEREAS, the centerpiece of the National Government's project is known as the Build, Build Infrastructure Program where the DOTr is one of the implementing arms and is tasked to promote and advance the development of an efficient and coordinated transportation system;

WHEREAS, DOTr shall implement the PNR South Commuter (Solis-Calamba) ("PNR SC") Project where a component of, and which extends to the North-South Commuter Railway Project (NSCR) shall traverse the City of Muntinlupa displacing a turber of its constituents;

WHEREAS while the partnership between the City Government of Muntinlupa (CGM), DO Tr and NR sought to implement an efficient transport system, the protection and the interest of the constituents of the COM are of prime importance;

WHEREAS, the creation of a Resettlement Action Plan Implementation and Management Committee, which composition is laid out in the MOA, will ensure compliance with the JICA-and ADB-approved Resettlement Action Plan(RAP) which ensures: (a) adverse social and physical impacts are avoided, minimized and/or mitigated, (b) Project-Affected Persons (PAPs) benefit from the Project, (c) PAPs are provided with sufficient compensation and assistance for lost asset so that none of them shall be worse off because of the Project and; (d) all stakeholders, especially PAPs, are duly consulted regarding the Project design, implementation and operation;

NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Jaime R. Fresnedi to enter into and sign in behalf of the City Government of Muntinlupa a Memorandum of Agreement (MOA) with the Department of Transportation (DOTr) represented by Timothy John R. Batan, Undersecretary for Railways and the Philippine National Railways (PNR) represented by General Manager Junn B. Magno for the creation of a Resettlement Action Plan Implementation And Management Committee (RIMC), likewise adopting the General and Particular Provisions and the Terms of Reference Included Thereon.

RESOLVED FURTHER, that to better represent the affected constituents of Muntinlupa, the Chairman of the Committee on Urban Poor of the Sangguniang Panlungsod shall be part of the composition of the RIMC.

ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 5th day of October 2020, on its 65th Regular Session.
