WHEREAS, Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project Construction of Road and Drainage located at South Greenheights, Barangay Putatan, Muntinlupa City in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;
