A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH MARCBUILT CONSTRUCTION INC., FOR THE PROJECT ASPHALT OVERLAY LOCATED AT TIOSEJO SUBDIVISION, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION, EIGHT HUNDRED EIGHT THOUSAND, TWO HUNDRED SIXTY PESOS (PHP2,808,260.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 SUPPLEMENTAL BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).




