WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, " xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others.

df **WHEREAS**, Article 86 (b) (1) (vi) of the Implementing Rules and Regulation of the Local Government Code of 1991, provides that, "***the City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances***"

WHEREAS, the City Government of Muntinlupa advertisement advertised the invitation to apply for eligibility and to bid for the project ***construction of Sewerage Treatment Plant (STP) located at Muntinlupa City Hall, National Road, Barangay Putatan, Muntinlupa City***, in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;
