A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH AYANA CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF SEWERAGE TREATMENT PLANT (STP) LOCATED AT MUNTINLUPA CITY HALL, NATIONAL ROAD, BARANGAY PUTATAN, MUNTINLUPA CITY AMOUNTING TO SIX MILLION SEVEN HUNDRED NINETEEN THOUSAND SIX HUNDRED FORTY-ONE PESOS AND 42/100 (PHP6,719,641.42) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF)

WHEREAS, there is one (1) Bidder who submitted its Bid on **August 18, 2020** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa:

WHEREAS, after careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the above bidder with the lowest calculated Bid, Ayana Construction Corporation, its bid proposal has been found to be **RESPONSIVE** for the project **construction of Sewerage Treatment Plant (STP)** located at **Muntinlupa City Hall, National Road, Barangay Putatan, Muntinlupa City**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Ayana Construction and Trading's** its bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Six Million Seven Hundred Thirty-Eight Thousand Nine Hundred Twelve Pesos and 59/100 (Php6,738,912.59)**;
