WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulation of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project completion works for the construction of High School Building located at MNHS Annex, Southville 3, Barangay Poblacion, Muntinlupa City in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their letter of intent and application for eligibility and was found eligible on August 11, 2020;

WHEREAS, there is one (1) Bidder who submitted its Bid on August 11, 2020 and Passed the Preliminary Examination of Bid at the City Administration Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa:

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, Starcross Corporation Inc.'s bid has been responsive to Approved Budget for the Contract (ABC) amounting to Twenty-One Million Nine Hundred Seventy-eight Thousand Seven Hundred Thirty-Four Pesos and 44/100 (*Php21,978,734.44*);

WHEREAS, the project was awarded to Starcross Construction Inc., which being the lowest bidder for the project completion works for the construction of High School Building located at MNHS Annex, Southville 3, Barangay Poblacion, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Starcross Construction Inc., for the project completion works for the construction of High School Building located at MNHS Annex, Southville 3, Barangay Poblacion, Muntinlupa City in the amount of Twenty-One Million Nine Hundred Sixty-Six Thousand Six Hundred Five Pesos And 75/100 (Php21,966,605.75) which amount shall be taken from 2020 Local School Board Fund.
