WHEREAS, both Article III, Section 8(d) of the City Charter of Muntinlupa (Republic Act 7926) and Section 454(d) of the (Republic Act 7160), otherwise known as the Local Government Code of 1991 provide that, *"unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed"*;

WHEREAS, the mandate of the Committee on Personnel Administration under Rule VIII (s) of the Internal Rules of Procedure for the 9th **Sangguniang Panlungsod of Muntinlupa** to confirm all appointments made by the Honorable City Mayor is derived from Article III, Section 8(d) of Republic Act 7926, otherwise known as the **"City Charter of Muntinlupa"** which provides as follows:

"Unless otherwise provided herein, all appointed city officials of the City shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod Members, subject to Civil Service Law, Rules and Regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, by virtue Article VI, Section 1(5) of City Ordinance No. 03-089, otherwise known as the Charter of Paman. tasan ng Lungsod ng Muntinlupa, enacted on March 20, 2003, ***“the Vice President for Academic Affairs who shall be appointed by the Chairman, shall serve for a term of four (4) years, renewable for another 4 years, unless sooner removed for a cause. His powers and duties shall be prescribed by the Board of Regents”.***

WHEREAS, there is a need to confirm the Position of Dr. Amado Lanting Magsino as University Vice President III for Academic.

WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the appointment of Dr. Amado Lanting Magsino as **University Vice President III** at the **Pamantasan ng Lungsod ng Muntinlupa-Office of the Vice President for Academic Affairs** and has submitted the same for the confirmation by the City Council;

WHEREAS, Dr. Amado Lanting Magsino, finished his Primary Education at Banjo Laurel Elementary School in 1971 and Secondary Education at Our Lady of Fatima Academy in 1975, graduated at Philippine Christian University with the degree of Bachelor in Business Administration in 1985, graduate studies at Laguna of College of Business with the degree of Master in Business Administration and Arts in 1996, and Colegio de San Juan de Letran Calamba with the degree of Doctor of Philosophy in Management;

WHEREAS, Dr. Amado Lanting Magsino, passed the Examination for Career Service Professional with a passing grade in 1986;

WHEREAS, Dr. Amado Lanting Magsino, is a resident of #043 President Laurel Highway, Darasa, Tanauan City, Batangas.

WHEREAS, Dr. Amado Lanting Magsino, started his career in private colleges to wit:
