FRESNEDI TO ENTER AND SIGN INTO A SERVICE AGREEMENT (SA) WITH INTEGRATED WASTE MANAGEMENT, INC., (TRANSPORT/TREATER) FOR THE COLLECTION AND TRANSPORTATION OF HAZARDOUS HEALTHCARE WASTE FROM THE CITY HEALTH OFFICE AND HEALTH CENTER FACILITIES OF THE CITY GOVERNMENT OF MUNTINLUPA

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Section 22(a) (4-5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "every local government unit, as a corporation, shall have the following powers:

5. To enter into a contract;

WHEREAS, Section 22(c) of the same Code further provide that, "unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned";

WHEREAS, Section 48 of Article XVI of Republic Act No. 9154, otherwise known as the **"Government Procurement Reform Act, provides that, in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, shopping and negotiated procurement"**;

WHEREAS, Section 53 of Article XVI of Republic Act No. 9154, otherwise known as the "Government Procurement Reform Act, provides that, "negotiated procurement is a method of procurement of goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

53.9. Small Value Procurement. Where the procurement does not fall under shopping in Section 52 of this IRR and the amount involved does not exceed the threshold xxx"

53.9.1. "The procuring entity shall draw a list of three (3) suppliers, contractors or consultants of known qualification which will be invited to submit proposals. In the case of goods and infrastructure projects, or curriculum vitae, in case of consulting services."

WHEREAS, the **Integrated Waste Management Inc.**, is a corporation duly organized and existing under the laws of the Republic of the Philippines with business address at 3rd Floor, Cargohaus Building, NAIA Complex, Barangay Vitalez, Parañaque City;

WHEREAS, the Integrated Waste Management Inc., (Transporter/Treater) agrees to serve the City government of Muntinlupa (Generator) by collecting and transporting its hazardous healthcare waste of City Health Office (CHO) and all Health Center Facilities within the City;

WHEREAS, the **Integrated Waste Management Inc.**, (Transporter/Treater) shall collect healthcare waste from City Government of Muntinlupa (Generator) twice (2) a month based on the schedule to be determined and provided by the Transporter/Treater;

WHEREAS, there is an appropriated budget from the 2020 Executive Budget for the Service Contract as certified by the City Budget and Management Department (CBMD) and included in the approved APP/PPMP of the entity;

WHEREAS, the payment terms shall be the following:

Monthly Service Fee	Php3,500.00 inclusive of VAT
Fee for excess weight 100 kilograms	35.00 per kilogram inclusive of VAT
Fee for addition day of waste collection	Php650.00 inclusive of VAT






