A RESOLUTION AUTHORIZING THE CITY MAYOR TO REPRESENT THE CITY OF MUNTINLUPA IN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) REPRESENTED BY CORAZON I. FLORES, MD, OFFICER IN CHARGE-DIRECTOR, ON THE PROVISION OF SERVICES RELATIVE TO HIV, AIDS, STD, WHICH INCLUDES ACCESS TO ANTI-RETROVIRAL DRUGS FOR PEOPLE LIVING WITH HIV (PLHIV).

WHEREAS, SEC. 455 (a) (vi) of Republic Act 7160, otherwise known as the Local Government Code, provides that the city mayor, as chief executive of the city government, shall exercise such powers and perform such duties and functions as provided by the Code and other laws and shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance;

WHEREAS, Section 23 of Republic Act 11166 or An Act Strengthening the Philippine Comprehensive Policy on Human Immunodeficiency Virus (HIV) and Acquired Immune Deficiency Syndrome (AIDS) Prevention, Treatment, Care, and Support, and, Reconstituting the Philippine National Aids Council (PNAC), mandates the PNAC, in coordination with the DOH, LGUs, and other relevant government agencies, private sector, CSOs, faith-based organizations, and PLHIVs, to implement preventive measures, safe practices and procedures;

WHEREAS, Article III of City Ordinance no. 15-146 otherwise known as an Ordinance Promulgating Policies and measures for the Prevention and Control of Sexually Transmitted Infection (STI) Human Immunodeficiency Virus (HIV) Acquired Immune Deficiency Syndrome (AIDS) in Muntinlupa City and Creating the Muntinlupa City Local Aids Council (MCLAC), designated and intensified the function of the Muntinlupa City Social Hygiene Clinic also known as the Muntinlupa Reproductive Health Clinic and Wellness Center (MRHCW) Room 101;

WHEREAS, the City Health Office (CHO) which is in control and supervision of the MRHCW Room 101, shall partner and collaborate with the DOH-MMCHD in the implementation of DOH Administrative Orders 27 series of 1994 and 18 series of 1995 in providing services related to HIV and AIDS;

WHEREAS, pursuant to the aforecited regulations, MRHCW Room 101, shall have access to Antiretroviral Drugs and is likewise authorized to dispense to PLHIV upon clinical evaluation of a trained physician using the standard WHO guidelines and in accordance with DOH policies and Guidelines;

WHEREAS, upon review, the City Legal Office interposed no objection to the execution of the **Memorandum of Agreement MOA**, and advised the MHRW to abide with the reportorial, confidentiality and monitoring provisions therewith;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by 9th Regular Session, to authorize the City Mayor to represent the City of Muntinlupa in a Memorandum of Agreement (MOA) with the **Department of Health Metro Manila Center for Health Development (DOH-MMCHD)** represented by Corazon I. Flores, MD, Officer in Charge-Director, on the provision of Services Relative to **HIV, AIDS, STD**, which includes access to **Anti-Retroviral Drugs for People Living with HIV (PLHIV)**.

ADOPTED, by the 9th **Sangguniang Panlungsod of Muntinlupa** this 19th day of October, 2020, on its 67th Regular Session.






