A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNED TO GRANT THE LOAN ASSISTANCE TO SAMAHAN NG MGA MAGKAKAPITBAHAY SA ILOG NG MUNTINLUPA, INC., (SAMASIM) ALSO KNOWN AS DIAMOND HILLS HOMEOWNERS ASSOCIATION, INC., LOCATED AT BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF TWO HUNDRED NINETY THOUSAND PESOS (PHP290,000.00) TO BE USED FOR THE PAYMENT OF GEODETIC SUBDIVISION SURVEY AND FOR THE APPROVAL OF SUBDIVISION PLAN AND INDIVIDUAL TECHNICAL DESCRIPTION OF THE TITLE, WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET- INTERIM FINANCING OF THE CITY.

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”**;

WHEREAS, the **SAMASIM Association** is seeking loan from the City Government of Muntinlupa in the amount of Two Hundred Ninety Thousand Pesos (Php290,000.00) to be used for the payment of geodetic subdivision survey and for the approval of subdivision plan and individual technical description of the title;
