WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, the SAMASIM Association is seeking loan from the City Government of Muntinupa in the amount of Two Hundred Ninety Thousand Pesos (Php290,000.00) to be used for the payment of geodetic subdivision survey and for the approval of subdivision

plan and individual technical description of the title;

WHEREAS, the SAMASIM has requested the City Government of Muntinlupa for a loan assistance in the amount of Two Hundred Ninety Thousand Pesos (Php290,000.00) from the Interim Financing of the City;

WHEREAS, there is a fund available under the Interim Financing of the 2020 Executive Budget of the City Government;

WHEREAS, the SAMASIM Association, has to pay the said loan within three (3) years based on the mode of payment incorporated in the Loan Agreement;

WHEREAS, the Association has agreed to pay the interest if they cannot pay the loan amount on the due date setforth in the Loan Agreement;
