WHEREAS, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 (LGC) provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 455 (b)(1)(vi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance";

WHEREAS, prior to the renewal of the contract, the existing services by Cablelink were assessed by its end-users in the CGM;

WHEREAS, Management Information and System Office (MISO) has consolidated the evaluation done and found out that the end-users are satisfied with Cablelink's service in terms of the Internet Speed and reliability of the internet connection;

WHEREAS, basing on the very satisfactory result of the evaluation, the MISO recommended the renewal and upgrade of the premium dedicated internet service of Cablelink for the City which is much very much needed in the gradual shift to the New Normal in holding meetings and communicating with clients and personnel;

WHEREAS, the present internet subscription capacity or bandwidth is 200 MBPS which will be upgraded up to 300 MBPS under the new contract which upgrade will be enable the City to have more efficient online services;
