WHEREAS, on March 2020, Republic Act No.11494 or the Bayanihan to Recover as One Act, declared a state of national emergency and granted unto the President of the Philippines the power to adopt temporary emergency measures to respond to the crisis brought about by the pandemic;

WHEREAS, Section 4 (v)(9) of the Bayanihan Actistates that, the President may direct the discontinuance of appropriated Programs, Projects or Activities (PPAs) of any agency of the Executive Department, including Government-Owned Or -Controlled Corporations (GOCCs), in the FYs 2019 and 2020 General Appropriations Act (GAA), whether released or unreleased, the allotments for which remain unobligated, and utilize the savings generated therefrom to augment the allocation to local government units for any item directly related to support the operations and response measures, which are necessary or beneficial in order to address the COVID-19 emergency;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 128 (LBC NO. 128) which set the Guidelines On the Release and Utilization of the Local Government Support Fund Covid-19 Financial Assistance to Local Government Units (LGSF-COVID 19 FA to LGUs) in the Bayanihan to Recover as One Act Republic Act No.11494;

WHEREAS, under LBC NO. 128, the appropriated amount for the LGSF-COVID-19 FA to LGUs under the "Bayanihan to Recover as One Act" shall be exclusively used for financial assistance to LGU s support the COVID-19 related **Programs**, **Projects**, and **Activities (PPAs)** and expenses which includes among others, the procurement of **Personal Protective Equipment (PPEs);** medicines and vitamins and hospital equipment and supplies;

WHEREAS, the City of Muntinlupa's Local Finance Committee, on 21st October, 2020, approved Resolution No. 9, Series of 2020 recommending the submission of request for the Local Government Support Fund (LGSF) to the DBM as part of the City's anti-Covid-19 efforts which includes the procurement of PPEs, medicines and vitamins and hospital equipment and supplies;

WHEREAS, likewise, the City has complied with the required documents set forth in LBC NO. 128 such as the preparation of Project/Program/Activities title, target beneficiaries, implementation process and period of implementation;

WHREAS, the amount of goods to be purchased under the program is Twenty-Two Million Two Hundred Forty Thousand Five Hundred Fifty Pesos (Php22,240,550.00) which procurement shall comply with the posting requirements prescribed under *Government Procurement Reform Act (R.A. No. 9184)* and its 2016 Revised IRR, and all relevant policies issued by the *Government Procurement Policy Board (GPPB)*, as well as the applicable budgeting, accounting and auditing Rules and Regulations;

NOW THEREFORE RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to endorse the programs and projects proposed in the Local Finance Committee Resolution No. 9, Series of 2020, to the **Department of Budget and Management (DBM)** pursuant to DBM Local Budget Circular No. 128, Implementing Bayanihan to Recover as One Act (Republic Act 11494) Local Government Support Fund (LGSF) against Covid-19.
