WHEREAS, on March 2020, Republic Act No. 11494 or the Bayanihan to Recover as One Act, declared a state of national emergency and granted unto the President of the Philippines the power to adopt temporary emergency measures to respond to the crisis brought about by the pandemic;

WHEREAS, Section 4 (v)(9) of the Bayanihan Act states that, the President may direct the discontinuance of appropriated Programs, Projects or Activities (PPAs) of any agency of the Executive Department, including Government-Owned Or -Controlled Corporations (GOCCs), in the FYs 2019 and 2020 General Appropriations Act (GAA), whether released or unreleased, the allotments for which remain unobligated, and utilize the savings generated therefrom to augment the allocation to local government units for any item directly related to support the operations and response measures, which are necessary or beneficial in order to address the COVID-19 emergency;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 128 (LBC NO. 128) which set the Guidelines On the Release and Utilization of the Local Government Support Fund Covid-19 Financial Assistance to Local Government Units (LGSF-COVID 19 FA to LGUs) in the Bayanihan to Recover as One Act Republic Act No. 11494;
