A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KME. DESIGN & CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF NEW MUNTINLUPA CITY PUBLIC MARKET (PHASE 2) LOCATED AT BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF ONE HUNDRED EIGHTY-FOUR MILLION EIGHT HUNDRED THOUSAND PESOS (PHP184,800,000.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND

WHEREAS, the authority given by the 9th Sangguniang Panlungsod to the City Mayor Atty. Jaime R. Fresnedi to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project *construction of New Muntinlupa City Public Market (Phase 2) located at Barangay Alabang, Muntinlupa City* in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS), and City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, the project was awarded to KME. Design & Construction which is the lowest bidder for the project construction of New Muntinlupa City Public Market (Phase 2) located at Barangay Alabang, Muntinlupa City;
