WHEREAS, Sec. 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991 (LGC of 1991), provides that, "the sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall Approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection, shall, review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punong Barangay";

WHEREAS, Section 391 of the LGC of 1991 likewise states, "the Sangguniang Barangay, as the legislative body of the barangay, shall enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein";


WHEREAS, on Sept 29, 2020, Barangay Ayala Alabang endorsed to the City Council Ordinance No. 09-01 series of 2020 also known as "An Ordinance Establishing a Molecular Diagnostics Laboratory in Barangay Ayala Alabang" (Molecular Ordinance);

WHEREAS, the proposed Molecular Diagnostic Laboratory, a BIOSAFETY LEVEL 2 LABORATORY, shall be established within the jurisdiction of the barangay and shall cater not exclusively to the residents of Ayala Alabang but likewise to the public;
