WHEREAS, Republic Act No. 11032 also known as the “**Ease of Doing Business Act**” calls for the implementation of unified procedures and taxes, fees and charges, in securing business license and mayor’s permit or permit for legal operation of any callings and dealings thereof;

WHEREAS, the “**Ease of Doing Business Act**”, mandate local government units to issue the appropriate ordinance to adopt guidelines issued by national agencies concerned for proper implementation of the streamlined procedures for the proper issuance of business licenses, barangay clearances, permits and authorizations;

WHEREAS, Chapter 2 Section 57(a), of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, “**xxx the Sangguniang Barangay shall furnish copies of all barangay ordinances to the Sangguniang Panlungsod or xxx concerned for review as to whether the ordinance is consistent with law, city or municipal ordinances**”;

WHEREAS, the City Council approved Ordinance No. 19-032, or “**An ordinance on collection of corresponding Barangay Clearance Fee in the application for any business related transaction**”, where the City, through the Business Permit and Licensing Office (BPLO) is authorized to collect barangay fees subject to the provisions thereof.

WHEREAS, the Association of the Barangay Captains of Muntinlupa City, through Liga ng mga Barangay Resolution No. 2020-05, approved a Unified Revenue Code, which code was adopted, approved and signed by the Punongbarangays of **Tunasan, Poblacion, Putatan, Bayanan, Alabang, Cupang, Buli and Sucat**,

WHEREAS, since the ordinance of the Association of Barangay Captains is in compliance with RA 11032 or to the "**Ease of Doing Business Act**", the City Council **interposes no objection** for the implementation of the said "**Unified Barangay Revenue (UBR)**" of the Liga ng mga Barangay;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to adopt the "**Unified Barangay Revenue (UBR)**" of the Liga ng mga Barangay.

ADOPTED, by the 9th **Sangguniang Panlungsod of Muntinlupa** this 3rd day of November, 2020, on its 69th Regular Session.
