WHEREAS, Section 458 of the Local Government Code of 1991 (RA7160), the Sangguniang Panlungsod, as the legislative body of the city, "shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of the said Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of the same";

WHEREAS, under RA 7160 Section 455 (2), "the local chief executive is empowered to enforce all laws and ordinances relative to the governance of the city, and in the exercise of the appropriate corporate powers provided for in Section 22 of RA 7160, implement all approved policies, programs, projects, services and activities of the city";

WHEREAS, on September 1, 2020 the Sangguniang Panlungsod enacted Ordinance No. 2020-123, or an Ordinance adopting the fees to be collected for the utilization of Muntinlupa Public Crematorium through the Community Affairs Office (CADO) where under Section 4 thereon, the CADO shall prepare the Implementing Rules and Regulations (IRR) for the effective and proper implementation of aforementioned ordinance;

WHEREAS, in compliance with the provision of Ordinance 2020-123, the Executive submitted an Implementing Rules and Regulation (IRR), and the same is found to be consistent and within the provisions of the Ordinance No. 2020-123;
