WHEREAS, Republic Act of 9729, also known as the Climate Change Act of 2009, mandates the Local Government Units (LGUs) as frontline agencies to formulate their Local Climate Change Action Plans, consistent with the provisions of the Republic Act No. 7160 otherwise known as the Local Government Code (LGC) of 1991 and the National Climate Change Action Plan (NCCAP);

WHEREAS, on April 2, 2018, the Sanggunian adopted Resolution No. 18-298 otherwise known as A Resolution Adopting the Ten Years Muntinlupa Climate Change Action Plan (MCCAP) 2017-2027 which embodies the city's mother plan to address the climate changes brought about by global warning;

WHEREAS, the City of Muntinlupa, through the *Environment Protection and Natural Resources Office (EPNRO)*, endorsed the Muntinlupa Enhanced Climate Change Plan (MECCAP), which is an enhanced version of the MCCAP and incorporates the recent developments in the national climate change policy including the mitigation aspect of climate change;

WHEREAS, the MECCAP is anchored on the Climate Change Act (RA 9729) which provides the policy framework to systematically address the growing threats on community life and its impact on the environment while being responsive to the onset of events that are catastrophic over the medium and long-term;

WHEREAS, it is imperative that at the onset of COVID-19, policies on health, sanitation, local disaster preparedness and all climate change-related issues should be re-aligned to conform to the "new normal", and should include guidelines on the waste disposal, proper management and use of electricity and water, sustainable transport and

climate-resilient intrastructures;
