A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA, TO ENTER INTO A CONSTRUCTION AGREEMENT WITH D.L. CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF TRACK AND FIELD (PHASE 1 & 2) LOCATED AT SPORTS COMPLEX, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE HUNDRED ONE MILLION ONE HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED FORTY-SEVEN PESOS AND 11/100 (PHP101,188,947.11) WHICH AMOUNT SHALL BE TAKEN FROM 2019 CONTINUING APPROPRIATION AND 2020 EXECUTIVE BUDGET UNDER THE INFRASTRUCTURE FUND

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **construction of track and field (Phase 1 & 2)** located at **Sports Complex, Barangay Tunasan, Muntinlupa City** in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS), City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **September 29, 2020**;

WHEREAS, there is one (1) Bidder who submitted its Bid on **September 29, 2020** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **D.L. Cervantes Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **One Hundred One Million Nine Hundred Ninety-Nine Thousand Three Pesos and 64/100 (Php101,999,003.64)**;

WHEREAS, the project was awarded to **D.L. Cervantes Construction Corporation** which is the lowest bidder for the project **construction of track and field (Phase 1 & 2)** located at **Sports Complex, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th **Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Atty. Jaime R. 




