WHEREAS, under Section 4 (8) of the **Implementing Rules And Regulations (IRR) Of Republic Act No. 10121**, Also Known As "An Act Strengthening The Philippine Disaster Risk Reduction And Management System, Providing For The National Disaster Risk Reduction And Management Framework And Institutionalizing The National Disaster Risk Reduction And Management Plan, Appropriating Funds Therefor And For Other Purposes", states that the city Disaster Risk Reduction and Management Officers (DRRMOs), in coordination with concerned national agencies and instrumentalities, shall prepare and submit to the local sanggunian through the Local Disaster Risk Reduction and Management Office (LDRRMC) and the Local Development Council (LDC) the annual Local Disaster Risk Reduction and Management Office (LDRRMO) Plan and budget, the proposed programming of the Local Disaster Risk Reduction and Management Fund (LDRRMF), other dedicated disaster risk reduction and management resources, and other regular funding source/s and budgetary support of the LDRRMO;

WHEREAS, likewise **Rule 18, Section 1** of the IRR of Republic Act 10121, provides that the LDRRMF shall be set aside to support disaster risk management activities such as, but not limited to, pre-disaster preparedness programs including training, purchasing life-saving rescue equipment, supplies and medicines, for post-disaster activities, for the payment of premiums on calamity insurance and construction of evacuation centers and upon the recommendation of the LDRRMO and approval of the sanggunian concerned, the LDRRMC may transfer the said fund to support disaster risk reduction work of other LDRRMCs which are declared under state of calamity;

**WHEREAS**, Resolution No. 2020-01, adopted by the LDRRMC on November 6, 2020 resolved to grant Financial Assistance in the amount of Ten Million Pesos (Php10,000,000.00) which amount shall be apportioned to the twenty-one (21) local government units in various provinces;

**WHEREAS**, the Department of Disaster Resilience and Management (DDRM) of the City Government of Muntinlupa, have an approved 2020 AIP for Formulation of Flood Control/Drainage Master Plan which budget may be used for Disaster Recovery and Rehabilitation Program for local Government units devastated by calamity/disaster;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to approving the Supplemental Annual Investment Program (AIP) for Calendar Year 2020 of the Department of Disaster Resilience and Management to accommodate humanitarian assistance and rapid need assessment/financial assistance to calamity/disaster victims and provision of disaster relief goods (Assistance to Other Local Government Units declared in A State of Calamity.)
