WHEREAS, Article XII, Section 6, of the 1987 Constitution states that, "*The State shall apply the principles of agrarian reform and stewardship, whenever applicable in accordance with law, in the disposition or utilization of natural resources, including lands of public domain xxx.*";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "*(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "*unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.*";

WHEREAS, The Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) is one of the sectoral councils under the Department of Science and Technology (DOST) and was formed through the consolidation of the Philippine Council for Agriculture, Forestry and Natural Resources Research and Development (PCARRD) and the Philippine Council for Aquatic and Marine Research and Development (PCAMRD) on June 22, 2011 pursuant to Executive Order No. 366;

WHEREAS, Galing-PCAARRD Program has various components and one of which is the Gulayan sa Pamayanan which is basically a vegetable gardening program using science and technology interventions that aims to ensure food availability, productivity and sustainability within the community provide livelihood and improve the quality of life of the marginalized sectors in the NCR and recognizes the benefits of establishing communal garden in the Region;

WHEREAS, the parties to the Memorandum of Understanding undertakes various obligations with the end view to make available and sustain food availability in the community in the times of pandemic and beyond;

WHEREAS, the City Government of Muntinlupa recognizes its role in building a sustainable city for its constituents thereby partnering with the DOST-NCR, Department of Agriculture Extension Services Office and Barangay Sucat to embark on its journey to empower communities to produce their own food and generate sustainable source of food stability during the pandemic time;

WHEREAS, the Gulayan sa Pamayanan Project under the Galing PCAARD Program commences on June 2020 to May 2021;

WHEREAS, the Legal Office interposes no objection to the terms and conditions under the MOA;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to sign and enter into a Memorandum of Understanding (MOU) with **Department Of Science And Technology-National Capital Region (DOST-NCR)** Represented By Regional Director Mr. Jose B. Patalinjug III, **Barangay Sucat, Muntinlupa City**, represented by its Barangay Chairman Rafael T. Sevilla, and **Doña Rosario Heights Subdivision Homeowners Association**, represented by its President Mr. Sidney Noel for the Gulayan Sa Pamayanan Project (GSP) under the Galing PICAARD Program.
