NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the _SangguniangPanlungsod, to authorize the City Mayor, Hon. Jaime R. Fresnedi to sign and execute documents pertaining to the housing loan of the City Government of Muntinlupa for the construction of buildings for *Employees Centennial Housing Project* and to apply and negotiate for a Funding Commitment Line (CFL) through Home Development Mutual Fund (Pag-IBIG) take-out mechanism under the Developers/Contract to Sell scheme, in the amount of *Five Hundred Forty Million Twenty Four Thousand Pesos (PhP540,024,000.00)* subject to such terms and conditions as may be provided by the fund.
