GARMA, ON THE ALLOCATION OF LOTTO AND SMALL TOWN LOTTERY (STL) SHARES FROM THE CHARITY FUND AND CALAMITY ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGUS).

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) was created under Philippine Legislature Act No. 4130 on October 30, 1934 and later amended by Republic Act No. 1169 in 1954 and Batas Pambansa Blg. 42 on September 24, 1979. It is the principal government agency for raising and providing funds for health programs, medical assistance and services, and charities of national character.

WHEREAS, under RA 1169, the PCSO, by authority of the Office of the President, shall dispose gross receipts from sale of tickets for races in the amount corresponding to six percent (6%) for cities to be expended for the maintenance of provincial, city and municipal hospitals, and for other health, social welfare, and charitable work in their respective jurisdiction

WHEREAS, Executive Order No. 357, as amended, provides for the proportional grant of thirty percent (30%) Lotto Charity Fund in favor of local government units where lotto tickets are sold, and the city is authorized to receive its share of the Lotto Charity Fund in the amount corresponding to five (5%) percent."

WHEREAS, Section 22 of the same Code states that, "every local Government Unit, as a corporation, shall have the following powers:



WHEREAS, Article 86 (b) (1) (vi) and Article 86 (b) (1) (viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that. "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government unit without prior authorization by the Sangguniang concerned";

WHEREAS, the City of Muntinlupa (CGM), represented in the MOA, by its Local Chief Executive, Mayor Jaime R. Fresnedi, shall receive its share from the gross receipts from sales of Lotto and STL and shall obligate itself to comply with all the guidelines appurtenant to its use;

WHEREAS, as to the grant of Calamity Assistance, the CGM shall likewise accept the amount granted by PCSO and comply with the corresponding obligation attached therein:

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor, Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MOA) with Philippine Charity Sweepstakes Office (PCSO), represented by General Manager Royina M. Garma, on the allocation of Lotto and Small Town Lottery (STL) shares from the Charity Fund and Calamity Assistance to Local Government Units (LGUS).

ADOPTED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 7<sup>th</sup> day of December, 2020, on its 74<sup>th</sup> Regular Session.
