FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JADOMINIA CONSTRUCTION & SUPPLIES FOR THE PROJECT REHABILITATION OF WINDOWS AND INSTALLATION OF EXHAUST LOCATED AT 5TH FLOOR PLMUN COLLEGE BUILDING, BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION SIX HUNDRED THIRTY-FIVE THOUSAND THREE HUNDRED SEVENTY PESOS (PHP2,635,370.00) WHICH AMOUNT SHALL BE TAKEN FROM 2019 EXECUTIVE BUDGET UNDER INFRA FUND

WHEREAS, the procedures of negotiated procurement will be observed and followed, pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184;

WHEREAS, the authority given by the 9th Sangguniang Panlungsod to the City Mayor Atty. Jaime R. Fresnedi to enter into a **Construction Agreement** is based on the documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertisement~~s~~ advertised the invitation to apply for eligibility and to bid for the project improvement of PLMUN (**rehabilitation of windows and installation of exhaust**) located at **5th Floor PLMun College Building, Barangay Poblacion, Muntinlupa City** in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in view of two (2) failed bidding, the City Government of Muntinlupa thru the **Bids and Awards Committee (BAC)** posted, at its own website and conspicuous place within its premises an invitation to submit proposals, complete with terms, delivery, delivery schedule and technical specifications, for the project improvements of **PLMUN (rehabilitation of windows and installation of exhaust)** located at **5th Floor PLMun College Building, Barangay Poblacion, Muntinlupa City**;

WHEREAS, the sealed proposal received were then forwarded by the **BAC** to the **Technical Working Group (TWG)** for its evaluation and recommendation;

WHEREAS, the BAC is in the receipt of favorable recommendation from the TWG for the award of the contract to **JADOMINIA Construction & Supplies** a contractor of known technical, legal and financial competence, at the negotiated price of **Two Million Six Hundred Thirty-Five Thousand Three Hundred Seventy Pesos (Php2,635,370.00)**;

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Jadominia Construction & Supplies's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Two Million Six Hundred Forty-Three Thousand Nine Hundred Sixty Pesos 34/100 (Php2,643,960.34)**;

WHEREAS, the project was awarded to **Jadominia Construction & Supplies** who being the lowest bidder for the project improvement PLMUN (**rehabilitation of windows and installation of exhaust**) located at **5th Floor PLMun College Building, Barangay Poblacion, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Jadominia Construction & Supplies** for the project improvement of PLMUN (rehabilitation of windows and installation of exhaust) located at 5th Floor PLMun College Building, Barangay Poblacion, Muntinlupa City in the amount of **Two Million Six Hundred Thirty-Five Thousand Three Hundred Seventy Pesos (Php2,635,370.00)** which amount shall be taken from **2019 Executive Budget Under Infra Fund**.
