WHEREAS, The Sangguniang Panlungsod pursuant to Section 16 of the Local Government Code of 1991, which states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, passed Resolution Number 2020-170 otherwise known as a Resolution Authorizing The City Mayor To Procure Polymerase Chain Reaction (PCR) Machines And Testing Kits, For Use By The Ospital Ng Muntinlupa, Subject To The Approval Of The Department Of Health (DOH);

WHEREAS, to efficiently address the continuing threat of COVID-19, the City Government of Muntinlupa converted the Saklolo at Gabay ng Ina at Pamilya (SAGIP) Center Building into a Molecular Laboratory at the Ospital ng Muntinlupa (OSMUN);

WHEREAS, Executive Order No. 118, directed DOH in coordination with the Department of Trade and Industry, to ensure accessibility and affordability of Covid-19 tests and test kits thereby mandating the DOH to determine, formulate and implement a price range of Covid-19 testing conducted by hospitals, laboratories and other health establishments and facilities;

WHEREAS, considering the DOH's limited maximum pricing and the PHilhealth reimbursable amount for accredited testing facilities for Covid Swab test and SARS-COV2 Test Package respectively, the Ospital ng Muntinlupa recommended an affordable Covid-19 RT-PCR test which will produce an effective and reliable result;
