A RESOLUTION AUTHORIZING THE CITY MAYOR, ATTY. JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY REGIONAL DIRECTOR VICENTE GREGORIO B. TOMAS ON THE FACILITATION OF THE PAY OUT AND DISTRIBUTION OF SOCIAL PENSION (SOCPEN) TO INDIGENT SENIOR CITIZENS PURSUANT TO BAYANIHAN TO RECOVER AS ONE ACT

WHEREAS, Article XII, Section 6, of the 1987 Constitution states that, *"The State shall apply the principles of agrarian reform and stewardship, whenever applicable in accordance with law, in the disposition or utilization of natural resources, including lands of public domain xxx."*;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that *"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."*;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, *"unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."*;

**WHEREAS**, under Section 4(pp) of Republic Act 11494 or the Bayanihan to Recover as One Act, the Department of Social Welfare and Development (DSWD) has been given authority to transfer funds to Local Government Units (LGUs) for purposes of facilitating the distribution of social pension for indigent senior citizens (SOCPEN) to fast track the distribution of emergency subsidy to these targets beneficiaries;

**WHEREAS**, the City Government of Muntinlupa (CGM), one of LGU-beneficiaries of the subsidy under RA 11494, actively participated in the pay-out of SOCPEN and faithfully liquidated the grant for the first semester of calendar year 2020;

**WHEREAS**, another SOCPEN grant for the Second Semester will be transferred to the CGM which will cover: a. the pay out of unclaimed pension for the First Semester of 2020 and; b. the distribution of SOCPEN for the Second Semester (July to December) of 2020;

**WHEREAS**, under the MOA, the CGM, thru Social Services Department (SSD) shall be responsible for the following: a. shall ensure the proper processing of the list of unpaid senior citizen beneficiaries for Social Pension (SOCPEN) for Calendar Year 2020 and produce the appropriate payroll/s, arranged or disaggregated, per Barangay; b. liquidation of funds within the period of twenty (20) calendar days from the date of last distribution or payout of subsidy and submit liquidation response; c. processing and validation of the list of unpaid senior citizens per Barangay, distributing the social pension to qualified beneficiaries, d. documenting grievances and liquidation of funds within twenty (20) calendar days from the date of last distribution or pay out, e. submission of liquidation report and refund of unclaimed funds within five (5) days from the submission of liquidation;

**WHEREAS**, the City Legal Office interposes no objection to the provisions stipulated in the MOA;

**NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor, Atty. Jaime R. Fresnedi** to enter into a **Memorandum of Agreement (MOA)** with the **Department of Social Welfare and Development (DSWD)** represented by Regional Director Vicente Gregorio B. Tomas on the facilitation of the pay out and distribution of **Social Pension (SOCPEN)** to indigent senior citizens pursuant to Bayanihan to Recover as One Act.

**ADOPTED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 14<sup>th</sup> day of December, 2020, on its 75<sup>th</sup> Regular Session.
