A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH CSL CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE BUILDING (JRF PAVILION) LOCATED AT MUTUAL HOMES, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF TWELVE MILLION SEVEN HUNDRED SIXTY-FOUR THOUSAND TWO HUNDRED THIRTY-SIX PESOS AND 43/100 (PHP12,764,236.43) WHICH AMOUNT SHALL BE TAKEN FROM THE 2020 EXECUTIVE BUDGET

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **CSL Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Twelve Million Eight Hundred Fourteen Thousand Seven Hundred Fifty-Six Pesos and 52/100 (Php12,814,756.52)**;

WHEREAS, the project was awarded to **CSL Construction Corporation** who being the lowest bidder for the **project** construction of Multi-Purpose Building (JRF Pavilion) located at Mutual Homes, Barangay Putatan, Muntinlupa City;
