AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE FAMILIES AFFECTED BY CONFLAGRATION ON JANUARY 17, 2021, AT NO. 341 SITIO BISAYA, BARANGAY ALABANG, MUNTINLUPA CITY AMOUNTING TO TWO MILLION FOUR HUNDRED FIFTY-FOUR THOUSAND PESOS (PHP2,454,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2021 EXECUTIVE BUDGET

WHEREAS, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare of the city and its inhabitants and shall:

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx":

WHEREAS, on January 17, 2021 at 8:20 a.m., a fire broke out at No. 341 Sitio Bisaya, Barangay Alabang, Muntinlupa City;

WHEREAS, in a final report of casualties, damage to properties and action taken/ rendered by the *City Social Services Department* dated *January 20, 2021*, the following data resulted, to wit:



1. One Hundred Forty-Two (142) structures;

2. Three Hundred Fifty-Four (354) families;

3. One Thousand Eighty-Five (1,085) individuals.

WHEREAS, the reported *Three Hundred Fifty-Four (354)* families affected by the fire comprised of house owners, renters and sharers who were rendered homeless by reason of the said conflagration;

**WHEREAS**, the **Social Service Department** (SSD) of the City of Muntinlupa, is given the authority to determine the homeowners, renters and sharers and recommended the provision of financial assistance as follows:

	AMOUNT OF
AFFECTED FAMILIES/INDIVIDUALS CATEGORY	FINANCIAL ASSISTANCE
House owners totally damaged	Php10,000.00
House owners partially damaged	3,000.00
House owners totally damaged (not residing in the area)	5,000.00
Renters and Sharers	Php 5,000.00

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 9<sup>th</sup> Sangguniang Panlungsod, to grant financial assistance to the families affected by conflagration on *January 17, 2021,* at *No. 341 Sitio Bisaya, Barangay Alabang, Muntinlupa City* amounting to Two Million Four Hundred Fifty-Four Thousand Pesos (PHP2,454,000.00) which amount shall be taken from the 2021 Executive Budget.

ENACTED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 18<sup>th</sup> day of January 2021, on its 80<sup>th</sup> Regular Session.
