ORDINANCE NO. 2021-223

AN ORDINANCE IMPOSING CURFEW OF 8:00 PM TO 5:00 AM IN THE CITY OF MUNTINLUPA STARTING APRIL 12 UNTIL APRIL 30, 2021 DURING THE MODIFIED ENHANCED COMMUNITY QUARANTINE PURSUANT TO THE RESOLUTION OF THE METRO MANILA COUNCIL

WHEREAS, on September 16, 2020 **President Rodrigo Roa Duterte** issued Proclamation No. 1021 (series of 2020) extending the period of the State of Calamity throughout the Philippines until September 21, 2021;

WHEREAS, the Department of Health (DOH), the **University of the Philippines-Genome Center and the University of the Philippines-National Institute of Health** bio surveillance has detected variants of COVID-19 virus;

WHEREAS, to stop the continuous spread of the virus and its variants, the Sanggunian adopted the uniform curfew hours resolved by the Metro Manila Council during the Enhanced Community Quarantine (ECQ) of NCR Plus Bubble;

WHEREAS, the **Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-MEID)** Resolution NO. 109-A series of 2021 declared **that beginning April 12, 2021, the National Capital Region and the Provinces of Bulacan, Cavite, Laguna, Rizal shall be placed under Modified Enhanced Community Quarantine (MECQ) until April 30, 2021;**

WHEREAS, on April 11, 2021, the **Metro Manila Council (MMC)** have agreed to impose new curfew hours across the metropolis starting **April 12** until the end of the MECQ on **April 30, 2021;**

NOW THEREFORE BE IT ENACTED, by the 9th Sangguniang Panlungsod duly assembled the following:

SECTION 1. **Title.** This ordinance shall be known as the "MECQ Curfew Ordinance for the period April 12-30, 2021;"

SECTION 2. Curfew Period. The new curfew hours for the period April 12-30, 2021 shall be 8:00pm to 5:00am.

SECTION 3. Exemption. Authorized Persons Outside of Residence (APOR) shall be exempted from the implementation of this ordinance provided they show proof of identification or certificate of employment to authorities;

SECTION 4. Operations of Commercial Establishments. Operations of Commercial establishments shall be covered by the Omnibus Guidelines on the Implementation of Community Quarantines (with amendments as of April 02,2021);

SECTION 5. Penalty. Any person violating this Ordinance shall be meted with the following penalties, without prejudice to the charges under R.A. No.11469 and R.A. 11332, which penalizes non-cooperation of persons or entities during a health event of public concern:

- a. **First Offense - Fine amounting to Three Hundred Pesos (PhP300.00)**
- b. **Second Offense - Fine amounting to Five Hundred Pesos (PhP500.00)**
- c. **Third and Subsequent Offenses - Fine amounting to One Thousand Pesos (PhP1,000.00)**

For minor violators, the following penalties shall be imposed and the fine shall be charged against their parents or guardian/s, as applicable:

- a. **First Offense - Stern warning.**
- b. **Second Offense - Withdrawal of scholarship grants from the local government. For non-grantee, a fine amounting to Three Hundred Pesos (PhP300,00).**
- c. **Third and Subsequent Offenses - Fine amounting to Five Hundred Pesos (PhP500.00).**

SECTION 6. Separability Clause. If, for any reason or reasons, any parts or provisions of this Ordinance shall be held to be unconstitutional or invalid, other parts or provision/s hereof which are not affected thereby shall continue to in full force and effect

SECTION 7. Repealing Clause. All previous ordinances inconsistent with this Ordinance shall be deemed repealed or modified accordingly.

SECTION 8. Publication. This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the **Public Information Office (PIO)** in the Official Website of the City Government of Muntinlupa and in all available social media platforms, including posting in conspicuous places in Barangay Halls, Health Centers, Public Markets and other public places.
