AN ORDINANCE APPROVING THE 2021 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) ON THE UTILIZATION OF SPECIAL TRUST FUND (STF) COVERING THE UNEXPENDED AMOUNT FOR THE CALENDAR YEAR 2018 OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "Every Local Government Unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 2(l) of the Philippine Disaster Risk Reduction and Management Act of 2010 (R.A. No. 10121) declares that, "It is the policy of the State to recognize and strengthen the capacity of the LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters";

WHEREAS, Section 21, paragraph 3 of R.A. No. 10121 provides that, "Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMC's within the next five (5) years. Any such amount still not fully utilized after five years shall revert back to the general fund and will be available for other social services to be identified by the sanggunian."

WHEREAS, the Sangguniang Panlungsod enacted ordinance 2019-015 Approving The Utilization of the Special Trust Fund Covering the Unexpended Amount for Calendar Year 2018 of the Local Disaster Risk Reduction and Management Fund (LDRRMF) amounting to **Eighty-Four Million One Hundred Forty-Four Thousand Five Hundred Twenty Pesos (Php84,144,520.00)**;

WHEREAS, under Ordinance 2019-015, the unexpended balance was programmed to be used for information Communication Technology Equipment, Disaster Response & Rescue Equipment, Office Equipment, Training Expenses for DPA & BLS/FA but were not fully utilized during the year it was approved;

WHEREAS, the Special Trust Fund (STF) has the following balance as of December 11, 2020:

WHEREAS, the amount of *Sixty One Million One Hundred Ninety Seven Thousand Four Hundred Ten Pesos And Eighty Four Centavos (Php61,197,410.84)* is certified by the Office of the City Accountant as an unexpended balance of the STF Disaster Risk Reduction and Management Fund for **Calendar Year 2017-2018**, which may be used by the City Government in its Disaster Preparedness Programs;

WHEREAS, to support the utilization of the aforesaid Unexpended Balance, the DRRMO submitted the following revised **2021 Annual Investment Plan (AIP)**:

WHEREAS, specifically, the unexpended balance of the LDRRMF from the **Special Trust Fund (STF)** shall be used for the following:

Disaster Preparedness Programs:	
1. Ospital ng Muntinlupa	Php3,000,000.00
2. Enhancing and/upgrading of Muntinlupa City Emergency Operations Center and Citywide CCTV Facilities	43,788,410.84
3. Collegio de Muntinlupa	6,000,000.00
Maintenance and installation of Emergency Warning System (EWS):	
1. Installation of lighting arrester for Citywide out-door siren (13 Sites)	Php494,000.00
2. Installation of Rain Gauge for five (5) Barangays (Wireless/Web based/Software/Data Logger)	2,415,000.00
3. Improvement of Operations Center Facilities/Facilities/Equipment Room	5,500,000.00

NOW THEREFORE, BE IT ENACTED, by the **9th Sangguniang Panlungsod of Muntinlupa**, to approve the **2021 Local Disaster Risk Reduction and Investment Management Fund Investment Plan (LDRRMFIP)** on the utilization of **Special Trust Fund (STF)** covering the unexpended amount for the **Calendar Year 2018 of the Local Disaster Risk Reduction and Management Fund**.
