AN ORDINANCE AUTHORIZING THE GRANT OF HAZARD PAY TO THE PERSONNEL OF THE CITY GOVERNMENT OF MUNTINLUPA WHO PHYSICALLY REPORTED FOR WORK DURING THE IMPLEMENTATION OF AN ENHANCED COMMUNITY QUARANTINE (ECQ)

WHEREAS, Section 458(viii) of Republic Act 7160, "*empowers the Sangguniang Panlungsod to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, services, and activities of the City Government*";

WHEREAS, Administrative Order (AO) No. 43, series of 2020, "*authorized the grant of Hazard Pay to government personnel who physically reported for work during the period of implementation of Enhance Community Quarantine (ECQ)*";

WHEREAS, Local Finance Committee (LFC) in its **Resolution No. 09**, series of 2021 dated July 8, 2021, recommended the grant of **One Hundred Pesos (Php100.00)** per day to the **Five Thousand One Hundred Thirty-Two (5,132)** city employees for the period **March 27 to May 14, 2021**;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 9th Sangguniang Panlungsod in Session assembled that:

SECTION 1. **Short Title** – this ordinance shall be known as the “**ECQ Hazard Pay**”.

SECTION 2. **Coverage and amount of Hazard Pay.** Hazard Pay shall be granted to **permanent, casual, Job Order, Kabalikat, Barangay Health Worker, (BHW), and those engaged by Contract of Service** in the amount of **One Hundred Pesos (Php100.00)** per day of physical presence in work during the Enhanced Community Quarantine or **March 27 to May 14, 2021.**

SECTION 3. **Appropriation.** The City Budget Officer is hereby directed to allocate the amount of **Fifteen Million Eight Hundred Eighty-Three Thousand Seven Hundred Pesos (Php15,883,700.00)** representing the total Hazard Pay payable to the covered employees.

SECTION 4. **Effectivity Clause.** This ordinance shall take effect after its approval.

ENACTED, by the 9th Sangguniang Panlungsod this 26th day of July 2021, on its 107 Regular Session.
