WHEREAS, Article II, Section 17 of 1987 Constitution, provides that, *The state shall give priority to education, culture, and sports to foster patriotism and nationalism, accelerate social progress to promote total human liberation and development.*;

WHEREAS, access and quality education of our children is a government priority in conformance and support the United Nation's sustainable development goal;

WHEREAS, the three (3) year average population growth rate of the Philippines in 2020 is 1.38% and that the composition of the country's school-age population at present is 41% (as of December 2020, Philippine Demographics), thus, a need to establish new schools to effectively and efficiency deliver basic education in the City of Muntinlupa;

WHEREAS, the *Muntinlupa National High School Tunasan Annex* started its operations on **April 30, 2012** initially offering Junior High School and became a completer secondary school in **SY: 2012-2013**, and began offering **Senior High School** on **June 2016** under Republic Act No. 10533;

WHEREAS, DepEd's Department Order No. 5, series of 1999, stipulates that, *new secondary schools may be established in municipalities and cities when there is an urgent need and after satisfying all the requirements setforth therein*;

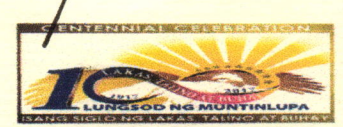

WHEREAS, there is a need to create and establish an additional national high school to be located in **Barangay Tunasan** to cater the needs of the growing students' population specifically those residing in **Barangays Tunasan, Poblacion, and lower Putatan**;

WHEREAS, *Muntinlupa National High School Tunasan Annex* satisfies the requirements as stated in DepEd Order No. 40, 2014 on the establishment, merging, conversation, and naming/renaming of public school annexes in Basic Education;

WHEREAS, the continuing surge in the number of enrollment in both Junior and Senior High Schools due to its strategic location and accessibility to learners, the school necessitates sustainable facilities, building, human resources to cope with learners and community demands;

WHEREAS, *Muntinlupa National High School Tunasan Annex* has a **School ID: 320704**, with **114 Junior High School Teachers** – with 40% which are detailed from other schools, **51 Senior High School Teachers**, and **receiving an MOOE allocation separate from the Mother School**;

WHEREAS, the Mother School – *Muntinlupa National High School Main* has recommended to the **Schools Division Office**, the transfer of *teaching and non-teaching personnel* to *Muntinlupa National High School Tunasan Annex* under the existing DepEd-DBM staffing standards for Secondary Schools;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa, that *Muntinlupa National High School Annex* be separated from *Muntinlupa National High School Main*, renamed, and established as **Tunasan National High School**.

ENACTED, by the 9th *Sangguniang Panlungsod of Muntinlupa* this 2nd day of **August 2021**, on its 108th Regular Session.
