AN ORDINANCE MODIFYING THE SALARY GRADE OF NURSES POSITION IN THE DEPARTMENT OF DISASTER, RISK REDUCTION AND MITIGATION (DDRM) TO CONFORM TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) BUDGET CIRCULAR NO. 2021-02, AMENDING FOR THIS PURPOSE ORDINANCE NO. 2021-225 AND ORDINANCE NO. 2021-098

**WHEREAS**, Section 458 (a) (VIII) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "**the Sangguniang Panlungsod is empowered to determine the positions, salaries, wages and other emoluments and benefits of officials and employees, paid wholly or mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government**";

**WHEREAS**, Article 99 of the Rules and Regulations Implementing the Local Government Code of 1991, provides that, "**the Sangguniang Panlungsod, as the legislative body of the City shall enact ordinances approve resolutions and appropriate funds for the general welfare of the city**";

**WHEREAS**, Article 163 of Rules and Regulations Implementing the Local Government Code of 1991, provides that, "**the Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its priority, need service requirements and financial capabilities, consistent with the principles of simplicity, efficiency, economy, effectiveness, dynamism and public accountability subject to the minimum standards and guidelines prescribed by the Civil Services Commission (CSC)**";

**WHEREAS**, DBM Budget Circular no. 2020-02 provides for the Modification of Nurse Position, prescribing the rules and regulations on the upgrading of the previous Nurse II positions by one (1) Salary Grade (SG), as well as to provide the administrative processes for the retention of the position titles of Nurse III to Nurse VII with their corresponding SG assignments in compliance with the Office of the President's directive to take the necessary action to implement the upgrading of the former Nurse II position by one (1) SG, i.e., from SG-15 to SG-16, as well as the retention of the position titles of Nurse III to Nurse VII with their corresponding SGs;

**WHEREAS**, prior to **DBM Budget Circular 2020-01**, the 9<sup>TH</sup> Sangguniang Panlungsod enacted Ordinances No. 2020-098 and 2021-225, which, in essence, Re-Organized/Re-Structured the personnel component of the Muntinlupa City Disaster Risk Reduction and Management Office (MCDRRM) to include the Nurses positions thereat;

**WHEREAS**, to conform to **Budget Circular No. 2021-2**, issued on August 25, 2021, there is a need to modify the Nurses position in the MCDRRM;

**NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the 9<sup>th</sup> Sangguniang Panlungsod in Session assembled that:

**SECTION 1. Title** – This ordinance shall be known as “**Modification of Nurse Positions in the MCDRRM**”.

**SECTION 2. Amendments** - Section 3 of Ordinance No. 2021-225 and Section 3 of Ordinance No. 2020-098

**SHALL NOW BE READ AS FOLLOWS:**

The existing Nurse II and Nurse III Plantilla/ Regular Positions under the MCDRRM is hereby amended/modified to Nurse III and Nurse IV, respectively. Hence,
