ORDINANCE NO. 2021-299

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE TWENTY-ONE (21) FAMILIES AFFECTED BY CONFLAGRATION ON DECEMBER 11, 2021, AT NO. 23 INTERIOR, PUROK 1, BARANGAY CUPANG, MUNTINLUPA CITY AMOUNTING TO ONE HUNDRED FORTY-THREE THOUSAND PESOS (PHP143,000.00)

WHEREAS, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

WHEREAS, on December 11, 2021 at 1:10 p.m., one (1) structure, consisting of twenty (20) families, were gutted by fire at No. 23 Interior Purok 1, Barangay Cupang, Muntinlupa City;

WHEREAS, on December 20, 2021 the Social Service Department (SSD) /submitted final report to the City Council of the affected families to wit:

- 1. One (1) structure;
- 2. Twenty (20) families;
- 3. Seventy-One (71) individuals;

WHEREAS, the owners of the house, renter/sharers, were rendered homeless by reason of the said conflagration;
