AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 FOR FY 2021 OF BARANGAY AYALA-ALABANG, AMOUNTING TO SIXTEEN MILLION EIGHT HUNDRED PESOS (PHP16,800,000.00) TO BE TAKEN FROM THE NEW REVENUE SOURCE (ACTUAL RECEIPT)-SALES OF ANTIGEN SWAB TEST

WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall:

(i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the Budget Office endorsed and recommended to the Sangguniang Panlungsod the **Supplemental Budget III** of **Barangay Ayala-Alabang** amounting to **Sixteen Million Eight Hundred Pesos (Php16,800,000.00)**;

WHEREAS, the following are the sources of fund of Barangay Ayala-Alabang came from the **New Revenue Source (actual receipt)-sales of antigen swab amounting to Sixteen Million Eight Hundred Pesos (Php16,800,000.00)** as certified by the Barangay Treasurer and Acting City Accountant.

WHEREAS, the **Supplemental Budget No. (III)** is allocated as follows:

Ordinance No. 2021-300

WHEREAS, the Supplemental Appropriation Ordinance No. 11-02, series of 2021, dated November 18, 2021 **declared to be operative** in its **entirety** on **December 16, 2021**. As it shows substantial compliance with the same law and its implementing rules and regulations (IRR) but still subject to the posting requirements under Section 59 of R.A. No. 7160.

WHEREAS, the disbursement thereof shall be in accordance with the existing Budgeting, Accounting and auditing rules and regulations as well as the established compensation laws, rules, policies and guidance;

WHEREAS, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No. 9184 (Government Procurement Reform Act) and its Revised Implementing Rules and Regulations (IRR) and prior clearances from pertinent agencies as maybe appropriate /needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan (AIP);

WHEREAS, allocation shall be available exclusively for the specific purposes for which they have been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of Treasury except in pursuance of an Appropriation Ordinance or Law;

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa, to approve the **Supplemental Budget No. 3** for FY 2021 of **Barangay Ayala-Alabang**, amounting to **Sixteen Million Eight Hundred Pesos (Php16,800,000.00)** to be taken from the **New Revenue Source (actual receipt)-sales of antigen swab tests**.

ENACTED, by the 9th **Sangguniang Panlungsod of Muntinlupa** this 20th day of **December 2021**, on its **128 Regular Session**.






