WHEREAS, Section 106 of Republic Act 7160 states that, “each local government unit (LGU) shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian”;

WHEREAS, the Department of Interior and Local Government (DILG) Memorandum Circular 2019-114 pronounced that, “the basis for investment planning and budgeting should be the Comprehensive Development Plan (CDP) which embodies the LGU’s vision and development goals, objectives and strategies in complement with the Executive-Legislative Agenda (ELA) as a plan document mutually developed and agreed upon by both the executive and legislative department of the LGU which sets the strategic directions of the city for the next three years”;

WHEREAS, on December 16, 2019, the Sangguniang Panlungsod adopted the Executive-Legislative Agenda (ELA) of the City of Muntinlupa for the period 2020-2022 through Resolution No. 19-159;

WHEREAS, pursuant to Section 106 of RA 7160, the Muntinlupa City Development Council (MCDC) formulated a medium-term socio-economic development plan and policies embodied in the Capacity Development Agenda for Fiscal year 2020-2022 and adopted by the MCDC on December 11, 2020 through Resolution No. 03 Series of 2020;

WHEREAS, the CAPDEV, crafted by the City, employed cascading of interventions to sectors and member offices/department and integration of released guidelines such as the Bayanihan Act, Omnibus Guidelines by the IATF for various Community Quarantines and Continuity Plan of Muntinlupa;
