WHEREAS, Section 106 of Republic Act 7160 states that, "each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian";

WHEREAS, the Local Development Investment Plan (LDIP), a mandated plan linking the budget, is the principal instrument for implementing the Comprehensive Development Plan (CDP) and to some extent, certain aspects of the Comprehensive Land Use Plan (CLUP);

WHEREAS, on December 11, 2020, the Muntinlupa City Development Council (MCDC), through MCDC Resolution No. 02-2020, adopted the Fiscal Year 2020-2022 Priority Projects for Local Development Investment Program (LDIP);

WHEREAS, the formulation of the City of Muntinlupa's LDIP, employed sectoral Prioritization Criteria of the list of programs and projects which consist of either new projects, regular programs that are deemed investible or expansion/ continuation of funding for existing projects;

WHEREAS, the adoption and approval of the LDIP for FY2020-2022 is crucial in the operations of the City Government of Muntinlupa;
