WHEREAS, Section 106 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "*mandates its local government to prepare a comprehensive multi-sectoral development plan to be initiated by Development Council and approved by its local Sanggunian. For this purpose, the development council at the city level shall assist the corresponding Sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction*";

WHEREAS, the Muntinlupa City Development Council (MCDC) approved the City's Comprehensive Land Use Plan (CLUP) 2016-2026 on 13 October 2015 via Resolution No. 2, Series of 2015 for endorsement to the Sangguniang Panlungsod for its endorsement to Metro Manila Council (MMC);

WHEREAS, to support the PPAs, the MCDC adopted the City's Comprehensive Development Plan (CDP) as sectoral plan of the approved CLUP 2016-2026 on August 18 2017 through Resolution No. 1, S. 2017 and on December 11, 2020, the MCDC passed Resolution No. 02-2020, adopting the Fiscal Year 2020-2022 Priority Projects for Local Development Investment Program (LDIP);

WHEREAS, the Sangguniang Panlungsod of Muntinlupa approved and adopted the Local Development and Investment Program for Fiscal Year 2020 to 2022 through Resolution No. 2021 -423 on January 11, 2021
