A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH ST. TIMOTHY CONSTRUCTION CORPORATION FOR THE PROJECT RENOVATION OF OPERATION CENTER & CONSTRUCTION OF PANTRY LOCATED AT RESILIENCY BUILDING, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF EIGHT MILLION NINE HUNDRED EIGHTY-THREE THOUSAND NINE HUNDRED SEVENTY-THREE PESOS AND 43/100 (PHP8,983,973.43) WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 EXECUTIVE BUDGET UNDER 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF)

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, "**The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, the authority given by the **Sangguniang Panlungsod** to the **City Mayor Rozzano Rufino B. Biazon** to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Renovation of Operation Center & Construction of Pantry** located at **Resiliency Building, Barangay Tunasan, Muntinlupa City**, likewise posted at the Philippine Government Electronic Procurement System (PhilGEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **October 4, 2022**;

WHEREAS, one (1) Bidder who submitted their Bid on **October 4, 2022** and bidder passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **St. Timothy Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Nine Million Thirty-Three Thousand Nine Hundred Eighty-three Pesos and 15/100 (Php9,033,983.15)**;

WHEREAS, the project was awarded to **St. Timothy Construction Corporation**, who being the lowest bidder for the project **Renovation of Operation Center & Construction of Pantry** located at **Resiliency Building, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **St. Timothy Construction Corporation** for the project **Renovation of Operation Center & Construction of Pantry** located at **Resiliency Building, Barangay Tunasan, Muntinlupa City** in the amount of **Eight Million Nine Hundred Eighty-Three Thousand Nine Hundred Seventy-Three Pesos and 43/100 (Php8,983,973.43)** which amount shall be taken from the **2022 Executive Budget Under 5% Local Disaster Risk Reduction and Management Fund (LDRRMF)**.




