A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. WHEREAS, the authority given by the Sangguniang Panlungsod to the City Mayor **Rozzano Rufino B. Biazon** to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Piping Distribution from main line to water metering block at Employees Housing located at Lakeview, Barangay Putatan, Muntinlupa City** likewise posted at the Philippine Government Electronic Procurement System (PhilGEPS) City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their letters of intent and applications for eligibility and were found eligible on **October 11, 2022**;

WHEREAS, there was one (1) Bidder who submitted its Bid on **October 11, 2022** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **KME Design & Construction's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Four Million Eight Hundred Ninety-One Thousand Seven Hundred Seventy-five Pesos and 16/100 (Php4,891,775.16)**;

WHEREAS, the project was awarded to **KME. Design & Construction** which is the lowest bidder for the project **Piping Distribution from main line to water metering block at Employees Housing located at Lakeview, Barangay Putatan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10<sup>th</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. **Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **KME Design & Construction** for the project **Piping Distribution from main line to water metering block at Employees Housing located at Lakeview, Barangay Putatan, Muntinlupa City** in the amount of **Four Million Eight Hundred Eighty Thousand Twenty Pesos And 04/100 (Php4,880,020.04)** which amount shall be taken from the **2022 Supplemental Budget No. 4 (Ordinance No. 2022-011) under Infra Fund**.






