

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project Construction of Perimeter Fence & Canopy Truss Extension located at Mutual Homes 1 & 2 Covered Court, Barangay Putatan, Muntinlupa City likewise posted at the Philippine Government Electronic Procurement System (PhilGEPS) City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on October 4, 2022;

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, Gemwealth Construction & Trading's its bid has been responsive to Approved Budget for the Contract (ABC) amounting to Three Million One Hundred Eighteen Thousand Two Hundred Twenty-Three Pesos and 25/100 (Php3,118,223.25);

WHEREAS, the project was awarded to Gemwealth Construction & Trading who being the lowest bidder for the project Construction of Perimeter Fence & Canopy Truss Extension located at Mutual Homes 1 & 2 Covered Court, Barangay Putatan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Rozzano Rufino B.
