WHEARES, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, *Eduardo T. Santos Construction & Supplies*'s bid has been responsive to Approved Budget for the Contract (ABC) amounting to Seven Million Eight Hundred Seventy-four Thousand Three Pesos and 05/100 (Php7,874,003.05);
