A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH EDUARDO T. SANTOS CONSTRUCTION SUPPLIES FOR THE PROJECT RENOVATION OF MAYOR'S OFFICE LOCATED AT SECOND FLOOR MAIN BUILDING, CITY HALL, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (PHP7,850,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 SUPPLEMENTAL BUDGET NO. 4 (ORDINANCE NO. 2022-011) UNDER INFRA-FUND

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, "The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, the authority given by the Sangguniang Panlungsod to the City Mayor Rozzano Rufino B. Biazon to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Renovation of Mayor's Office** located at **Second Floor Main Building, City Hall, Barangay Putatan, Muntinlupa City**, likewise posted at the Philippine Government Electronic Procurement System (PhilGEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and were found eligible on **October 11, 2022**;

WHEREAS, one (1) Bidder who submitted their Bid on **October 11, 2022** and bidder passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Eduardo T. Santos Construction & Supplies's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Seven Million Eight Hundred Seventy-four Thousand Three Pesos and 05/100 (Php7,874,003.05)**;

WHEREAS, the project was awarded to **Eduardo T. Santos Construction & Supplies**, who being the lowest bidder for the project **Renovation of Mayor's Office** located at **Second Floor Main Building, City Hall, Barangay Putatan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the City Mayor Hon. **Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Eduardo T. Santos Construction & Supplies** for the project **Renovation of Mayor's Office** located at **Second Floor Main Building, City Hall, Barangay Putatan, Muntinlupa City** in the amount of **Seven Million Eight Hundred Fifty Thousand Pesos (Php7,850,000.00)** which amount shall be taken from the **2022 Supplemental Budget No. 4 (Ordinance No. 2022-011) under Infra-Fund**.




