WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project *Roof Replacement of City Hall* located at *Main Building, Barangay Putatan, Muntinlupa City,* likewise posted at the Philippine Government Electronic Procurement System (PhilGEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and were found eligible on October 18, 2022;

WHEREAS, one (1) Bidder who submitted their Bid on **October 18**, **2022** and bidder passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEARES, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, *Eikonic Builders Inc.*,'s bid has been responsive to Approved Budget for the Contract (ABC) amounting to *Six Million Two Hundred Seventy-Three Thousand Seventy-One Pesos and 84/100 (Php6,273,071.84*);

WHEREAS, the project was awarded to *Eikonic Builders Inc.*, who being the lowest bidder for the project *Roof Replacement of City Hall* located at *Main Building*, *Barangay Putatan*, *Muntinlupa City*;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the City Mayor Hon. Rozzano Rufino B. Biazon, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Eikonic Builders Inc., for the project Roof Replacement of City Hall located at Main Building, Barangay Putatan, Muntinlupa City in the amount of Six Million One Hundred Fifty Thousand Ninety-Six Pesos And 73/100 (Php6,150,096.73) which amount shall be taken from the 2022 Supplemental Budget No. 4 (Ordinance No. 2022-011) under Infra-Fund.
