WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and were found eligible on **October 18, 2022**;

WHEREAS, one (1) Bidder who submitted their Bid on **October 18, 2022** and bidder passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Eikonic Builders Inc.**'s bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Six Million Two Hundred Seventy-Three Thousand Seventy-One Pesos and 84/100 (Php6,273,071.84)**;

WHEREAS, the project was awarded to **Eikonic Builders Inc.**, who being the lowest bidder for the project **Roof Replacement of City Hall** located at **Main Building, Barangay Putatan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Eikonic Builders Inc.**, for the project **Roof Replacement of City Hall** located at **Main Building, Barangay Putatan, Muntinlupa City** in the amount of **Six Million One Hundred Fifty Thousand Ninety-Six Pesos And 73/100 (Php6,150,096.73)** which amount shall be taken from the **2022 Supplemental Budget No. 4 (Ordinance No. 2022-011)** under **Infra-Fund**.
